

History

Sylvan Glen Golf Course is managed and operated by Billy Casper Golf (Resolution #2018-12-195) and includes the operation of the pro shop. Billy Casper Golf has indicated one of the most mentioned dissatisfactions related to the golf course is the condition of the pro shop. The pro shop was also a facility identified in the Facility Condition Assessment as requiring significant repairs. Renovating the existing pro shop verse constructing a new pro shop was extensively discussed during the 2020 budget discussions. Based on the originally proposed sized building by Billy Casper it was determined to budget \$300,000 to construct a new building at a more prominent location.

Shortly after the design conversations began it was recognized that the original proposed size building would not fully meet the needs of the pro shop. Because of this, City of Troy staff began designing a renovation to the current building in attempts to keep the project within the original budget.

OHM Advisors of Livonia, MI was tasked with collecting the needs and demands of the patrons and employees operating the pro shop and design a retail and office space to meet these requirements. The interior of the pro shop is proposed to be mostly reconfigured. Creating additional retail space by eliminating unused shower rooms and creating dedicated office space, breakroom, and storage.

Note that June 19, 2017 City Council awarded contracts to four (4) Engineering Consulting Services Firms. *OHM Advisors* is one of the firms the City utilizes. (Resolution #017-06-105-J-4a).

The current Sylvan Glen Clubhouse, which includes the Sylvan Glen Pro Shop and is also more commonly known as Camp Ticonderoga, is a locally designated historic facility as identified in Chapter 13 of the City of Troy Code. On September 16, 2019, the Troy Historic Commission met and resolved that the conceptual design of the Sylvan Glen Pro Shop renovation and alteration be approved as presented.

MITN provides a resourceful online platform to streamline the procurement process, reduce costs, and make it easier and more transparent for vendors to do business with the City of Troy.

Active MITN members with a current membership and paying annual dues receive automatic electronic notification which allows instant access to Bids, RFPS and Quote opportunities with the City.

Active MITN non-paying members are responsible to monitor and check the MITN website for opportunities to do business with the City. Inactive MITN member status can occur when a company does not renew their account upon expiration. Inactive members cannot be notified of solicitations or access any bid information.

• Usztan, LLC of Auburn Hills, MI is low bid as specified and meets all bid specifications.

Financial

Funds for the Sylvan Glen Pro Shop renovation project are budgeted in the Sylvan Glen Golf Course Fund for the total amount of \$300,000 with the associated Project Number of 2020C0055. The project exceeds the current budget amount by \$184,050.

Sylvan Glen currently has an advance receivable from Sanctuary Lake. In order to provide sufficient cash for the project, Sylvan Glen will need to exchange a portion of the advance receivable for cash with the General Fund. It is estimated that the exchange amount would be \$484,050. This would provide sufficient cash in the Sylvan Glen Golf Course Fund to complete the project and maintain sufficient cash reserves for operations.

Recommendation

City Management recommends awarding a contract for the Sylvan Glen Pro Shop Renovation to *Usztan LLC., of Auburn Hills, MI,* for an estimated grand total of \$375,500.00, which includes the acceptance of Alternate 1. Also, it is recommended that City Council give the authority to expend an additional \$111,200.00 which includes a 10% contingency amount and design fees for an estimated grand total of \$484,050.00 as detailed below.

ADDITIONAL INSURED – OWNERS, LESSEES OR CONTRACTORS – AUTOMATIC STATUS WHEN REQUIRED IN CONSTRUCTION CONTRACT OR AGREEMENT INCLUDING COMPLETED OPERATIONS – PRIMARY AND NONCONTRIBUTORY

This endorsement modifies the insurance provided under the following:

COMMERCIAL GENERAL LIABILITY COVERAGE FORM

- A. Section II Who Is An Insured is amended to include as an additional insured:
 - Any person or organization for whom you are performing operations when you and such person or organization have agreed in writing in a contract or agreement that such person or organization be added as an additional insured on your policy; and
 - Any other person or organization you are required to add as an additional insured under the contract or agreement described in Paragraph 1. above.

Such person(s) or organization(s) is an additional insured only with respect to liability for "bodily injury", "property damage" or "personal and advertising injury" caused, in whole or in part, by:

- a. Your acts or omissions; or
- The acts or omissions of those acting on your behalf;

in the performance of:

- a. your ongoing operations for the additional insured; or
- b. "Your work" for the additional insured and included in the "products – completed operations hazard".

However, the insurance afforded to such additional insured described above:

- a. Only applies to the extent permitted by law; and
- b. Will not be broader than that which you are required by the contract or agreement to provide for such additional insured.
- B. With respect to the insurance afforded to these additional insureds, the following additional exclusion applies:

This insurance does not apply to "bodily injury," "property damage" and "personal and advertising injury" arising out of the rendering of, or the failure to render, any professional architectural, engineering or surveying services including:

 The preparing, approving, or failing to prepare or approve maps, shop drawings, opinions, reports, surveys, field orders, change orders or drawings and specifications; or

 Supervisory, inspection, architectural or engineering activities.

This exclusion applies even if the claims against any insured allege negligence or other wrongdoing in the supervision, hiring, employment, training or monitoring of others by the insured, if the "occurrence" which caused the "bodily injury" or "property damage", or the offense which caused the "personal and advertising injury", involved the rendering of, or the failure to render, any professional architectural, engineering or surveying services.

 - b. 30 days before the effective date of cancellation if we cancel for any other reason.
