History

The Troy Police Honor Guard was formed to perform official remembrance ceremonies and funeral details for law enforcement professionals who have passed away in the line of duty. The Honor Guard also performs flag raising duties at various civic events that require a dignified display and presentation of our nation's flag. The Honor Guard is highly trained in the aspects of drill and ceremony, flag presentations, and funeral details.

The Troy Police Honor Guard Inc. is a 501c3 charity founded to give financial support to the families of law enforcement professionals in the State of Michigan who have passed away in the line of duty. They also fund projects and participate in ceremonies that memorialize law enforcement professionals. In support of these efforts the Troy Police Honor Guard participates in various fundraising initiatives.

The Troy Police Honor Guard has proposed to have a badge monument erected in front of the Police Department as a standing Memorial to all Law Enforcement Officers who have made the ultimate sacrifice in the line of duty. This monument will serve as a lasting symbol of the service and sacrifice of all Law Enforcement Officers, past, present and future and exemplify our core values of Integrity, Respect, Laws and the Constitution, Accountability, Problem Solving and Professionalism.

The Badge Monument project is estimated to cost approximately \$100,000.00. The Troy Police Honor Guard has conducted several fundraising activities to support this project and to date has raised approximately \$62,000.00.
