



QUESTION: Will the contractor be responsible for all engineering and layout?

ANSWER: The City's design consultant, AEW will be responsible for providing layout stakes.

QUESTION: Please confirm the below as referenced in specifications.

Page 48 of ITB
Pavement Restoration Sylvan Glen Pathway Project
Page 1

GENERAL

- a. This work shall consist of the replacement of the existing pavement (concrete or asphalt), sidewalks or driveway approaches disturbed during construction. All work shall conform to MDOT 2012 Standard Specifications for Construction.
- b. When no pay items appear in the proposal for pavement restoration it shall mean that payment is included in other proposal items of work.

ANSWER: Correct. The contractor shall be responsible for all restoration including any damage to hard surfaces, which is to be included in the bidders price.

QUESTION: Requesting a clarification that would reflect bond premium. There is a contradiction in the specs provided over the maintenance period. See bid proposal page 2 paragraph 7 & page 7 in the paragraph labeled "**Bond Submittal**"; where it states a two year maintenance period earlier within the documents page 2 of the bid proposal and later indicates a 1 year maintenance period. Can you clarify?

ANSWER: The maintenance period is 1 year from completion, which would likely entail mowing and fertilizing. The 2 year reference is referring to a warranty.

QUESTION: Can crushed concrete be used for the 21AA base material under the path? The specifications only reference limestone for the maintenance aggregate. If we are following MDOT spec, crushed concrete would be allowed as long as it is further than 100' from any water course.

ANSWER: Most of the trail is within 100' of the detention pond that drains into a county drain. Therefore limestone is specified for the entire project.

QUESTION: What type of backfill will be required for the Subgrade Undercutting, Type 1 item? As per MDOT specification, this would mean, "Backfill subgrade undercutting Type I with selected clay or other Engineer-approved material." The Geotechnical reports suggest backfilling undercut areas with 21AA. If 21AA is to be used can crushed concrete be used?

ANSWER: 21AA limestone shall be used.

QUESTION: Addendum No.1, Compiled Drawings, Sheet 3 shows "Headwall Detail" for 48" Culvert. Shall these headwalls be in lieu of 48" end sections or are we only installing end sections as indicated in bid proposal line item 15? Or, shall these headwalls not be included?

ANSWER: The headwall shall be installed in lieu of the 48" End Sections. The Bid Item "Culv, End Sect, Conc, 48 inch" has be removed and replace with pay item "headwall, Conc." Per Addendum No.1.

QUESTION: Pavement cross sections, Sheet 8 indicates removal of up to 6" of material and backfill with remaining material approved by engineer, what material does this refer to?

ANSWER: The backfill material to be used refers to the Engineered fill referenced in the G2 Soils report within the specifications, or Embankment, CIP which can be found in the MDOT 2012 Section on placing and compacting embankment within the roadway earthwork section. The Engineered fill or Embankment, CIP is a material free of organic matter, frozen soil, clods, or other harmful materials. Typically, existing on-site fill and native soils free of organic material are generally suitable for reuse as engineered fill. If imported material is required, MDOT Class II or III granular material will be suitable for fill in these areas.

QUESTION: Pavement section STA. 44+92 TO STA. 45+70 indicates removal of the same 6" of material as mentioned above, however states backfill with engineered fill, please specify backfill material for this area.

ANSWER: The answer to this question is the same as the previous. The note states "Backfill with remaining material approved by engineer or Embankment, CIP." If imported material is required, MDOT Class II or III granular material will be suitable for fill in these areas.

The following changes to and/or clarifications of the Contract Documents will be incorporated in said Contract Documents and such changes shall be allowed for in the price bid by the Contractor, such that the price indicated in the Proposal shall represent the conditions as set forth in the original Contract Documents as modified by this Addendum.

Subject: Standard Purchasing Resolution 2 – Low Bidder Meeting Specifications – Trail and Pathway Paving - Phase 2

History

Trails and Pathways has been a heavily discussed topic in the City of Troy. For the past several years trails and pathways have been included as a strategy and top initiative. "Re-evaluate the Trails & Pathways program with a focus on public participation and creative problem solving to build community support" is included as a 2019 strategy. Over the years, City Staff has applied for grants, held public engagement sessions, and recently constructed Phase One of the Troy Trail.

The first phase features a paved pathway approximately one mile in length that stretches from the Daisy Knight Dog Park to Wattles Road highlighting Troy's natural features in a wooded area.

In 2019, City Council was presented the proposed pathway for Phase Two of the Troy Trail in Sylvan Glen Lake Park. The second phase of the Troy Trail will begin in the parking lot at the park. A paved pathway will be constructed from the parking lot along the south edge of the lake and enter the wooded area. The trail will wind through the wooded area and provide connection to the adjacent subdivision. Phase two will continue to highlight Troy's natural resources while providing a new recreational opportunity.

Residents in the adjacent neighborhood were notified by mail of the proposed trail and asked to provide comments. Feedback was received regarding concerns for tree preservation and drainage which were both taken into consideration in the design process.

Anderson, Eckstein, and Westrick, Inc. (AEW), one of the City's professional service engineering firms (Resolution #2017-06-105-J-4a), has completed the Phase Two design drawings and specifications. AEW has also obtained necessary wetland and flood plain permits from the Michigan Department of Environment, Great Lakes, and Energy. With approval from City Council, the City will continue to use consultant AEW for construction management on this project.

Inactive members cannot be notified of solicitations or access any bid information.

- After reviewing the bid proposals with *AEW, Warren Contractors & Development, Inc. of Shelby Township, MI* was the low bidder meeting all specifications for the installation of the second phase of the Troy Trail and is being recommended.
- Attached is *AEW's* supporting documentation to this recommendation.
- Although *Warren Contractors & Development* was not the low bidder, they are the next lowest bidder meeting the *similar project completion* requirement.
- The low bidder did not meet this requirement because they did not have the necessary project experience as a primary contractor.

Funds are available in Capital Fund – Park – Trails & Pathways with an associated project number of 2021C0048. Expenditures will be charged to 401.751.770.7974.710.

Recommendation

City management recommends awarding a contract to install the second phase of the Troy Trail to the low bidder meeting specifications; *Warren Contractors & Development, Inc. of Shelby Township, MI* at the unit prices contained in the bid tabulations opened September 3, 2020 with an estimated total of \$549,671.25 and with a 15% contingency totaling \$82,450.69 but not to exceed budgetary limitations. The award is contingent upon the contractor's submission of properly executed bid documents including insurance certificates, and all other specified requirements.

History

In June of 2019 City Staff presented City Council a plan to construct Phase Two of the Troy Trail in Sylvan Glen Lake Park. Phase Two plans were consistent with the Green Space Subcommittee recommendations to improve Sylvan Glen Lake Park. The plan includes a paved pathway that stretches from the parking lot, along the south edge of the lake, into the wooded area abutting the golf course, and connects to the neighborhood to the west of the park.

Anderson, Eckstein, and Westrick, Inc. (AEW), one of the City's professional service engineering firms (Resolution #2017-06-105-J-4a), was tasked with design and engineering of Phase Two of the Troy Trail. Over the last several months AEW has completed the design drawings, specifications, and applied for permits with the Michigan Department of Environment, Great Lakes, and Energy for this project.

AEW has submitted a proposal to provide construction management services for Phase Two of Troy Trail. The proposal for construction management services includes review of bid, recommendation of award, oversight of trail construction, communication of project status to staff, coordinate all site testing, and to address all public questions and concerns.

Purchasing

The current contract with *Anderson, Eckstein, and Westrick, Inc. (AEW)* was adopted by City Council in 2017 for engineering and design services (Resolution #2017-06-105-J-4a). Under current contract pricing, AEW's construction management services are based off 11.04% of the trail's estimated construction cost plus the cost of construction testing by outside parties for an approximate total of \$70,032 per the attached proposal.

ADDITIONAL INSURED WRAP

This Endorsement modifies insurance provided under the following:
COMMERCIAL GENERAL LIABILITY COVERAGE PART

With respect to coverage provided by this Endorsement, the provisions of the Coverage Part apply unless modified by this Endorsement.

A. Additional Insured When Required By Written Agreement

1. Operations Performed For An Additional Insured

WHO IS AN INSURED is amended to include as an additional insured any person or organization for whom you are performing operations when you and such person or organization have agreed in a written agreement prior to a loss, that such person or organization be added as an additional insured on your policy. Such person or organization is an additional insured only with respect to liability for "bodily injury", "property damage" or "personal and advertising injury" caused, in whole or in part, by:

- a. Your acts or omissions; or
 - b. The acts or omissions of those acting on your behalf;
- in the performance of your ongoing operations for the additional insured.

A person's or organization's status as an additional insured under this provision ends at the earlier of when your operations for that additional insured are completed; or the end of the policy period.

2. Limitations

The Operations Performed For An Additional Insured coverage is limited as follows:

- a. This insurance does not apply to "bodily injury", "property damage" or "personal and advertising injury" arising out of the rendering of, or the failure to render, any professional architectural, engineering or surveying services, including:
 - (1) The preparing, approving, or failing to prepare or approve, maps, shop drawings, opinions, reports, surveys, field orders, change orders or drawings and specifications; or
 - (2) Supervisory, inspection, architectural or engineering activities.
- b. This insurance does not apply to "bodily injury" or "property damage" occurring after:
 - (1) All work, including materials, parts or equipment furnished in connection with such work, on the project (other than service, maintenance or repairs) to be performed by or on behalf of the additional insured(s) at the location of the covered operations has been completed; or
 - (2) That portion of "your work" out of which the injury or damage arises has been put to its intended use by any person or organization other than another contractor or subcontractor engaged in performing operations for a principal as a part of the same project.
- c. The Limits of Insurance applicable to the additional insured are those specified in the written agreement or in the Declarations for this policy, whichever is less. These Limits of Insurance are inclusive and not in addition to the Limits of Insurance shown in the Declarations. WHO IS AN INSURED is amended to include as an additional insured any person or organization, when you and such person or organization have agreed in a written agreement prior to a loss, that such person or organization be added as an additional insured on your policy, but only with respect to "bodily injury" or "property damage" caused, in whole or in part, by "your work" performed for that additional insured and included in the "products-completed operations hazard".

2. Limitations

The Additional Insured - Completed Operations coverage is limited as follows:

- a. This insurance does not apply to "bodily injury" or "property damage" arising out of the rendering of, or the failure to render, any professional architectural, engineering or surveying services, including:
 - (1) The preparing, approving, or failing to prepare or approve, maps, shop drawings, opinions, reports, surveys, field orders, change orders or drawings and specifications; or
 - (2) Supervisory, inspection, architectural or engineering activities.
- b. A person or organization's status as an insured under Additional Insured - Completed Operations continues only until the earlier of the end of the policy period; or the period of time required by the written agreement. If no time period is required by the written agreement, a person or organization's status as an additional insured under this endorsement will not apply beyond the lesser of the end of the policy period; or five years from the completion of "your work" on the project which is the subject of the written agreement.
- c. The insurance as provided to the additional insured does not apply to "bodily injury", "property damage" or "personal and advertising injury" arising out of "your work" for which a consolidated (wrap-up) insurance program has been provided by the prime contractor-project manager or owner of the construction project in which you are involved.
- d. The Limits of Insurance applicable to the additional insured are those specified in the written agreement or in the Declarations for this policy, whichever is less. These Limits of Insurance are inclusive and not in addition to the Limits of Insurance shown in the Declarations. If other insurance available to you and written by us is applicable to this additional insured, the maximum recovery under all coverage forms or policies combined may equal but not exceed the highest applicable limit under any one coverage form or policy providing coverage on either a primary or excess basis.
- e. The coverage provided to the additional insured by this endorsement and by paragraph f. of the definition of "insured contract" under DEFINITIONS do not apply to "bodily injury" or "property damage" arising out of the "products-completed operations hazard" unless required by the written agreement.
- f. This insurance does not apply if the person or organization required to be added as an additional insured is specifically named as an additional insured under any other provision of, or endorsement added to this policy.

C. Primary And Noncontributory

As respects the coverage provided under this endorsement, the Other Insurance Condition is amended as follows:

The paragraph regarding Excess Insurance is deleted and replaced with the following:

Excess Insurance

At our request, the insured will bring "suit" or transfer those rights to us and help us enforce them.

F. Additional Condition

The following condition is added:

Additional Insured Duty To Notify

The additional insured described in A. or B. above must give written notice of loss, including a demand for defense and indemnity, to any other insurer having coverage for the loss under its policies. Such notice must demand full coverage available and the additional insured shall not waive or limit such other available coverage.

A. AUTOMATIC ADDITIONAL INSURED – PRIMARY AND NONCONTRIBUTORY

SECTION II – COVERED AUTOS LIABILITY COVERAGE, subsection A. Coverage, paragraph 1. Who Is An Insured is amended to add:

d. (1) Automatic Additional Insured – Primary And Noncontributory

Any person or organization is an additional insured when you and such person or organization have agreed in writing prior to a loss that such person or organization be added as additional insured on your policy. Such person or organization is an additional insured only with respect to liability for "bodily injury" or "property damage" resulting from the ownership, maintenance or use of a covered "auto", provided the "bodily injury" or "property damage" is caused, in whole or in part, by you or by those acting on your behalf. This insurance is primary and is not contributing with any other insurance carried by the additional insured.
