- Kristine Kallek, Associate Buyer gave a brief overview of the Instructions to Bidders and the requirements for bid submission.
- The following questions were asked as vendors inspected the site.

QUESTION: Will RAP be allowed in the base or surface course HMA mixes? If so, at what percentage?

ANSWER: No, RAP will not be allowed in the base or surface course HMA mixes.

QUESTION: Have any pavement cores or soil borings been completed? If not, how do we quantify how much 21AA limestone to bid for this project. Should an amount be set this way contractors are bidding apples to apples? Not having pavement cores also poses another problem, for example what if the existing court is 4" thick? We have to remove the asphalt entirely to stone. We now have to add an inch of stone or HMA in order to get grades to match existing.

ANSWER: No, coring or soil samples have not been performed. The contractor shall include up to 500 tons and provide a line item pricing for additional tonnage.

QUESTION: Is the Asphalt lot connected to the tennis courts? If not, what is requested by the city for the gap between the two.

ANSWER: The tennis courts and parking lot are connected at the east and west respectively,

- Boulan Park is a 63-acre Community Park with a wide array of recreational opportunities.
- Boulan Park is home to eight tennis courts.
- The courts at Boulan Park are enjoyed by residents young and old alike including senior programing.
- The tennis courts were last resurfaced in 2006 and are beginning to fail.
- The 2020-2024 Parks and Recreation Master Plan, Resident Survey, identified maintaining existing recreation facilities as very important.

Purchasing

- On March 4, 2021 a bid opening was conducted as required by the City Charter/Code to furnish all material, labor, and equipment to resurface the existing tennis courts at Boulan Park.


MITN provides a resourceful online platform to streamline the procurement process, reduce costs, and make it easier and more transparent for vendors to do business with the City of Troy.

Active MITN mon-paying members are responsible to monitor and check the MITN website for opportunities to do business with the City.

Inactive MITN member status can occur when a company does not renew their account upon expiration. Inactive members cannot be notified of solicitations or access any bid information.
