Please be advised, the following additional questions have been submitted for clarification for ITB-COT 21-53, Pump Station Replacement. The clarification(s) and or change(s) will be considered an integral part of the original proposal document.

Request for clarification was received as follows:

QUESTION - What does the new stations GPM/PSI need to be?

ANSWER - The new station should be 1250 GPM/135 PSI.

QUESTION - Specification #14 Common Intake Header. Existing intakes are individual (as shown in the original delivery picture) HDPE was used with floaters out in the pond. I don't see a section specifying new intake, or foot valve in the pond need to be provided

ANSWER - It is the intention of the City of Troy to keep the same intakes and foot valves. There are two on the existing pump station and the specs are requesting one.

QUESTION - With the manufacturers lead time there is concern with the April 1st deadline.

ANSWER - Bidders that have concerns with meeting the deadline are encouraged to list an exception.

Budget Amendment and Standard Purchasing Resolution 2 – Low Bidder Meeting Specifications - Replacement of Pump Station located at the Sanctuary Lake Golf

Course (Introduced by Nikki McEachern, Assistant Recreation Director))

<u>History</u>

- Established in 2004, Sanctuary Lake is a par 71 links-style setting, 18 holes, and offers four sets of tees ranging from 4,750 to 6,555 yards.
- In 2010, Billy Casper Golf (now Indigo Golf) was awarded a management contract for Troy's two golf courses (Resolution #2010-06-123).
- The pump station assembly is used to draft water from the pond to irrigate the entire golf course.
- Using detained storm water from the pond is the exclusive method of irrigating the course.
- The original pump station assembly, consisting of the control board and pumps, has been repaired multiple times since its installation.
- The pump station assembly has reached the end of its reliable life. Repair parts are no longer available causing the full replacement of the pumps and controls.
- In efforts to limit disruption to irrigation efforts, it is recommended to replace the pump assembly when it is not in use.
- Failure to replace the pump station assembly could lead to the inability to irrigate the course with collected storm water from the pond, which would cause damage to the turf resulting in an unplayable course.
- Replacement of the pump station assembly was identified in the Facilities Condition Assessment and Analysis.

Purchasing

- On December 2, 2021, a bid opening was conducted as required by City Charter and Code to provide all equipment, material and labor for the pump station replacement at Sanctuary Lake Golf Course.
- The bid was posted on the Michigan Inter-governmental Trade Network (MITN) website; www.mitn.info.

<u>MITN</u> provides a resourceful online platform to streamline the procurement process, reduce costs, and make it easier and more transparent for vendors to do business with the City of Troy.

<u>Active MITN</u> members with a current membership and paying annual dues receive automatic electronic notification which allows instant access to Bids, RFPS and Quote opportunities with the City.

<u>Active MITN non-paying members</u> are responsible to monitor and check the MITN website for opportunities to do business with the City.

<u>Inactive MITN member</u> status can occur when a company does not renew their account upon expiration. Inactive members cannot be notified of solicitations or access any bid information.

- After reviewing the bid proposals Mid-Ohio Electric Company from Columbus, OH was the low bidder meeting all specifications for removal and installation of the Sanctuary Lake Golf Course pump station and is being recommended.
- Although Mid-Ohio Electric Company was not the low bidder, they are the next lowest bidder who
 could provide the full scope of work and meet our installation needs in the shortest amount of time
 which is critical to ensuring the course is irrigated properly for the upcoming season.
- The lowest bidder did not meet this requirement because their scope of work did not include dismantling and reconnection of the electrical portion of the project and their installation date was June 30 which is well into the golf season.

Financial

This project will require a budget amendment to the Sanctuary Lake Buildings and Improvements General Repairs Capital Fund for a not to exceed amount of \$170,500. Expenditures will be charged to account number 583,768,7975,900.

Recommendation

City management recommends awarding a contract to the low bidder meeting specifications *Mid-Ohio Electric Company of Columbus, OH* for the Replacement of the Pump Station at the Sanctuary Lake Golf Course at prices contained in the bid tabulation opened December 2, 2021 for an estimated cost of \$154,967.49 with a 10% contingency for a not to exceed amount of \$170,500. It is also recommended that City Council approve a budget amendment to the Sanctuary Lake Golf Course Building and Improvements General Repairs Capital Fund in the amount of \$170,500. The award is contingent upon the contractor's submission of properly executed insurance documents and all other specified requirements.
