**Standard Purchasing Resolution 2: Award to Low Bidder Meeting Specifications –  
Fire Hose Replacement Program for the Fire Department**

Resolution #2023-12-179-J-4b

RESOLVED, That Troy City Council hereby **AWARDS** a three (3) year contract with an option to renew for one (1) additional year for the Fire Hose Replacement Program to low bidder meeting specifications, *R&R Fire Truck Repair, Inc. of Northville, MI*, for Proposals A and B, to be purchased as specified and as needed; with an estimated total cost of \$34,043.80 for the 2024 fiscal year, and total estimated cost of \$40,000 over the next two (2) fiscal years, at the unit prices as contained in the bid tabulation opened November 16, 2023, a copy of which shall be **ATTACHED** to the original Minutes of this meeting, the cost of which **SHALL NOT EXCEED** annual budgetary limitations; with the contract expiring June 30, 2027.

BE IT FURTHER RESOLVED, That the award is **CONTINGENT** upon the contractor's submission of properly executed bid and proposal documents, including insurance certificates and all other specified requirements.

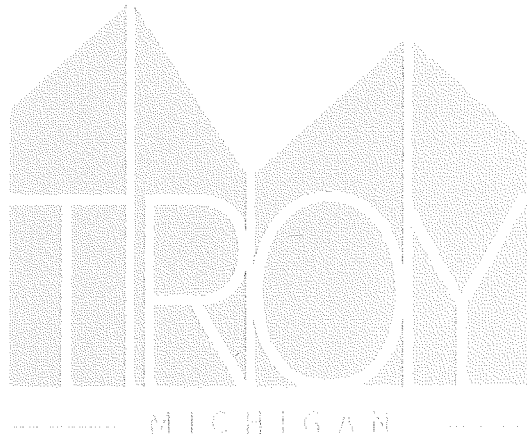

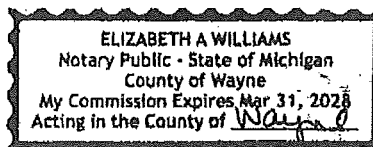

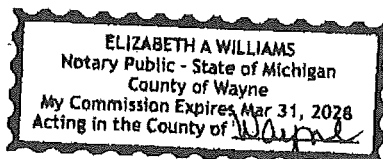

Subject: Standard Purchasing Resolution 2 - Award to Low Bidder meeting Specifications - Fire Hose Replacement Program for the Fire Department

### History

The Fire Department utilizes fire hoses of several different types, sizes, and colors for firefighting. National standards require all of the City's fire hose be performance tested on an annual basis. Due to fire hose failures during annual testing, and the national standard for fire hose service life requiring any hose manufactured prior to 1987 be removed from service, the Fire Department sought bids to replace damaged and outdated fire hose. The Fire Department has begun to replace over 55,000 feet of hose that does not meet the national standards. The Fire Department is also in the process of standardizing replacement options, and outfitting new apparatus.

### Purchasing

On November 16, 2023, a bid opening was conducted as required by City Charter and Code for three (3) requirements of fire hose replacements with an option to renew for one (1) additional year. The bid was posted on the MITN Purchasing Group website; [www.bidnetdirect.com//city-of-troy-mi](http://www.bidnetdirect.com//city-of-troy-mi). Sixty-six (66) vendors were notified via the MITN website. Three (3) bids were received. Below is a detailed summary of potential vendors:
