The last day to register in any manner other than in-person with the Troy City Clerk is **Monday, October 19, 2020**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the Troy City Clerk's Office, located at 500 W. Big Beaver Road, Troy, MI 48084 at the following times:

- Wednesday, October 14, 2020, from 8:00 a.m. to 7:00 p.m.
- Wednesday, October 21, 2020, from 8:00 a.m. to 7:00 p.m.
- Saturday, October 24, 2020, from 8:00 a.m. to 4:00 p.m.
- Friday, October 30, 2020, from 8:00 a.m. to 5:00 p.m.
- Saturday, October 31, 2020, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 3, 2020, from 7:00 a.m. to 8:00 p.m.
